PART B

DEFINITIONS

The words and phrases listed below will have the meaning attributed to them wherever they appear in the Policy unless the context otherwise requires.

- 1. "Accident" means a sudden, unforeseen and involuntary event caused by external, visible and violent means;
- 2. "Accidental Death Benefit Sum Assured" means an Accident cover amount chosen by You, as specified in the Schedule, which is payable in accordance with Clause 1.3 of Part C of the Policy;
- 3. "Accidental Death" means death which is caused by an Accident as revealed by an autopsy provided such death was caused directly by such Accident and independent of any physical or mental illness within 180 days of the date of Accident;
- 4. "Accidental Death Benefit Term" shall mean the term as specified in the Schedule, during which the Accidental Death benefit (defined above) will be available under the Policy. Accidental Death Benefit Term shall be same as the Policy Term or remaining Policy Term, as the case may be;
- 5. "Age" means Life Insured's age on last birthday as on the Date of Commencement of Risk or on the previous Policy Anniversary, as the case may be;
- 6. **"Annualised Premium"** is the amount specified in the Schedule, shall be Premium amount payable during a Policy Year, excluding Underwriting Extra Premiums, loadings for modal premiums, Rider Premiums and applicable taxes, cesses or levies;
- 7. **"Appointee"** means the person named by You (as applicable and registered with Us in the Schedule who is authorised to receive and hold in trust the benefits under this Policy on behalf of the Nominee/(s), if the Nominee/(s) is/are less than 18 years on the date of payment of the such benefit;
- 8. **"Assignment"** is the process of transferring the rights and benefits to an assignee, in accordance with the provisions of Section 38 of Insurance Act, 1938, as amended from time to time;
- 9. **"Claimant"** means You, nominee(s) (if valid nomination is effected), assignee(s) or their heirs, legal representatives or holders of a succession certificates in case nominee(s) or assignee(s) is/are not alive at the time of claim;
- 10. "Cover Option" means one of the following death cover options chosen by You on the Date of Commencement of Risk:
 - (i) **"Level Cover Option"-** wherein the Sum Assured on Death to be paid on death of the Life Insured, will remain level throughout the Policy Term.
 - (ii) "Increasing Cover Option"- wherein the Sum Assured on Death to be paid on death of the Life Insured increases by a simple rate of 5% per annum at each policy anniversary, subject to maximum of 200% of Sum Assured on Death chosen at inception. The Sum Assured on Death will increase only till completion of 21st Policy Year. The Sum Assured on Death will not increase from 22nd Policy Year onwards and will be the same as increased Sum Assured on Death effective as on the last Policy anniversary. In case of Joint Life Cover Option, only the Sum Assured on Death under the Policy for Life Insured shall increase under Increasing Cover Option.
- 11. **"Date of Commencement of Risk"/ "Date of Inception of Policy"** means the date as specified in the Schedule, on which the insurance coverage/risk under the Policy commences;
- 12. "Date of Issuance of Policy" means the date as specified in the Schedule on which this Policy is issued;
- 13. "Death Benefit" means the benefit which is payable on death of Life Insured, as stated in the Policy;
- 14. **"Death Benefit Variant"** means the option chosen by You at the time of the proposal and as specified in the Schedule. Once You have chosen the Death Benefit Variant at the time of proposal, the same cannot be changed by You during the Policy Term;
- 15. **"Diagnosis" or "Diagnosed"** means the definitive diagnosis made by a Medical Practitioner during Policy Term, based upon radiological, clinical, and histological or laboratory evidence acceptable to Us provided the same is acceptable and concurred by Our appointed Medical Practitioner. In the event of any doubt regarding the appropriateness or correctness of the Diagnosis, We will have the right to call for an examination of the Life Insured and/or the evidence used in arriving at such Diagnosis, by an independent expert selected by Us. The opinion of such an expert as to such Diagnosis shall be binding on both You and Us;
- 16. "Early Exit Value" shall have the meaning assigned to it in Clause 1 of part D of the Policy;
- 17. "Freelook" means a period during which, subject to the Clause 6 Part D of the Policy, You have an option to cancel the Policy and receive a refund of the Premium paid;
- 18. "Grace Period" means the time granted by Us from the due date for the payment of Premium, without any penalty or late fee, during which time the Policy is considered to be in-force with the risk cover without any interruption, as per the terms and conditions of the Policy. The Grace Period for payment of the premium for this Policy shall be 15 (Fifteen) days where You are paying on a monthly basis and 30 (Thirty) days in all other cases;
- 19. "Guaranteed Death Benefit" shall have the meaning assigned to it in Clause 1.1 of Part C of the Policy;
- 20. "Guaranteed Surrender Value" shall have the meaning assigned to it in Clause 1 of Part D of the Policy;
- 21. "Injury" means accidental physical bodily harm excluding illness or disease solely and directly caused by external, violent, visible and evident means, which is verified and certified by a Medical Practitioner;
- 22. "IRDAI" means the Insurance Regulatory and Development Authority of India;
- 23. "Joint Life Cover Option" means the option selected by You during the Proposal Form fulfilment wherein You may choose to cover Your spouse by paying an additional Premium as specified under Clause 1.6 of Part C;



- 24. "Lapsed Policy" means a Policy which has not acquired Surrender Value /Early Exit Value and where the due Premium(s) has not been received as per Clause 1.1 of Part D, if you have not opted for Return of Premium Option and as per Clause 1.2 and 1.3 of Part D, if You have opted for Return of Premium Option;
- 25. "Life Insured" means the person named in the Schedule, on whose life the Policy is effected;
- 26. **"Limited Premium Payment Variant"** means where the Premium Payment Term which is either 5, 10, 12 or 15 years with Policy Term ranging from 10 years to 67 years' subject to the Policy Term being greater than the Premium Payment Term by at least 5 years;
- 27. "Maturity Benefit" means benefit which is payable on maturity in accordance with Clause 1.4 of Part C of the Policy;
- 28. "Maturity Date" means the date specified in the Schedule, on which the Policy Term expires;
- 29. "**Medical Practitioner**" means a person who holds a valid registration from the Medical Council of any state or Medical Council of India or Council for Indian Medicine or for Homeopathy set up by the Government of India or a State Government and is thereby entitled to practice medicine within its jurisdiction and is acting within its scope and jurisdiction of license, provided such Medical Practitioner shall not include Your spouse, father (including step father), mother (including step mother), son (including step son), son's wife, daughter, daughter's husband, brother (including step brother) or sister (including step sister) or the Life Insured or You or employed by You/the Life Insured;
- 30. "Modal Factor" means the applicable factor specified in the Schedule, which is used by Us for determining the Premium. The Modal Factors for this Policy are as follows: i) for annual Premium payment mode (1.00); ii) for semi-annual Premium payment mode (0.513); iii) for quarterly Premium payment mode (0.261); iv) for monthly Premium payment mode (0.088);
- 31. **"Nomination"** is the process of nominating a person(s) in accordance with provisions of Section 39 of the Insurance Act, 1938 as amended from time to time;
- 32. **"Nominee"** means nominee nominated by You (only if You are the Life Insured) in accordance with Section 39 of Insurance Act, 1938 as amended from time to time, to receive the benefits under the Policy and whose name is mentioned in the Schedule;
- 33. **"Pay Till 60 Premium Payment Variant"** means that the Premium payable to Us during the Premium Payment Term shall be equal to 60 less Age, subject to minimum Premium Payment Term of 16 years. For this variant, the Premium Payment Term will always be lesser than Policy Term;
- 34. **"Policy"** means the contract of insurance entered into between You and Us as evidenced by this document, the Proposal Form, the Schedule, the Customer Information Sheet and any additional information/document(s) provided to Us in respect of the Proposal Form along with any written instructions from You subject to Our acceptance of the same and any endorsement issued by Us;
- 35. "Policy Anniversary" means the annual anniversary of the Date of Commencement of Risk;
- 36. "Policy Term" means the term of this Policy as specified in the Schedule;
- 37. **"Policy Year"** means a period of 12 (Twelve) months commencing from the Date of Commencement of Risk and every Policy Anniversary thereafter;
- 38. **"Premium"** means an amount specified in the Schedule, payable by You, by the due dates to secure the benefits under the Policy, excluding applicable taxes, cesses and levies, if any;
- 39. **Premium Break Option**" means the option selected by You during the Proposal Form fulfilment wherein You are allowed to take Premium waiver in accordance with Clause 1.7 of Part C
- 40. "Premium Payment Term" means the term specified in the Schedule, during which the Premiums are payable by You;
- 41. **"Proposal Form"** means the form filled in by You giving full particulars, for the purpose of obtaining insurance coverage under the Policy;
- 42. **"Regular Premium Payment Variant"** means that the Premium payable to Us in regular installments throughout the Premium Payment Term which is the same as the Policy Term, in the manner and at the intervals specified in the Schedule;
- 43. "Reduced Paid-Up Mode" means the Policy with reduced paid up benefits as specified under Clause 1.8 of Part C;
- 44. **"Reduced Paid-Up Sum Assured"** means the Policy with reduced paid up Sum Assured on Death as specified under Clause 1.8 of Part C;
- 45. **"Reduced Paid-Up Terminal Illness Benefit"** means the Policy with reduced paid up Terminal Illness Benefit as specified under Clause 1.8 of Part C;
- 46. **"Reduced Paid-Up Maturity Benefit"** means the Policy with reduced paid up maturity benefit as specified under Clause 1.8 of Part C;
- 47. **"Reduced Paid-Up Surrender Value"** means the Policy with reduced paid up Surrender Value or Early Exit Value as specified under Clause 1.8 of Part C;
- 48. **"Return of Premium Option"** means the option available under the Policy to be chosen by You at the time of Date of Inception of Policy, as per Clause 1.4 of Part C;
- 49. "**Revival**" means restoration by Us of the Policy, which was discontinued due to non-payment of Premium, by Us with all the benefits mentioned in the Policy document, upon the receipt of all the due Premiums and other charges or late fee if any , during the Revival Period, as per the terms and conditions of the Policy, upon being satisfied as to the continued insurability of the Life Insured or Policyholder on the basis of the information, documents and reports furnished by the Policyholder, in accordance with Board approved Underwriting Policy.;
- 50. "Revival Period" means a period of 5 (Five) consecutive years from the due date of the first unpaid Premium;
- 51. "Rider" means insurance cover(s) added to this Policy for Rider Premium;



- 52. **"Rider Premium"** means the premium amount payable in respect of a Rider applicable under the Policy and is the amount specified in the Schedule;
- 53. "Schedule" means the Policy schedule and any endorsements attached to and forming part of the Policy and if any updated Schedule is issued, then, the Schedule latest in time;
- 54. "Secondary Life" means Your spouse, in case You have opted for the Joint Life Cover Option as per Clause 1.6 of Part C of this Policy;
- 55. "Single Premium Payment Variant" means where the Premium is received in full in advance of the Date of Commencement of Risk;
- 56. "Special Exit Value" shall have the meaning assigned to it in Clause 1 of Part D of the Policy;
- 57. "Special Surrender Value" shall have the meaning assigned to it in Clause 1 of Part D of the Policy;
- 58. **"Sum Assured on Death"** means an absolute amount of benefit, which is guaranteed to become payable as per Clause 1.1 of Part C, on death of the Life Insured in accordance to terms and conditions of the Policy;
- 59. "Surrender" means complete withdrawal / termination of the entire Policy;
- 60. "Surrender Value" shall have the meaning assigned to it in Clause 1 of Part D;
- 61. **"Terminal Illness"** means a disease with which the Life Insured is Diagnosed with and in the opinion of a Medical Practitioner and Our appointed Medical Practitioner is likely to lead to the death of the Life Insured within 6 (Six) months from the date of such certification by the Medical Practitioner;
- 62. "Terminal Illness Benefit" shall have the meaning assigned to it in Clause 1.2 of Part C;
- 63. **"Total Premiums Paid"** means total of all the Premium paid under the Policy, excluding any extra Premium and applicable taxes if collected explicitly
- 64. **"Underwriting Extra Premium"** means an additional amount mentioned in the Schedule and charged by Us, as per Underwriting Policy, which is determined on the basis of disclosures made by You in the Proposal Form or any other information received by Us including the medical examination report of the Life Insured;
- 65. "Underwriting Policy" means an underwriting policy approved by Our board of directors;
- 66. **"Voluntary Sum Assured Top-Up"** means voluntary top-up to the Sum Assured by You to increase the Sum Assured on Death at a later stage in the Policy Term;
- 67. **"Voluntary Sum Assured Top-Up Option"** means an option available to You to do Voluntary Sum Assured Top-Up at a later stage during the Policy Term as per Clause 1.5 of Part C;
- 68. **"Waiting Period"** means a period 90 (Ninety) days in case of Policy sourced through point of sale as per Clause 1.1.4 of Part C and a period of 1 year, in case of Voluntary Sum Assured Top up as per Clause 1.5 of Part C, starting from the Date of Commencement of Risk or Date of Issuance of Policy or date of Revival, whichever is later;
- 69. "We", "Us" or "Our" means Axis Max Life Insurance Limited; and
- 70. "You" or "Your" means the policyholder as named in the Schedule.



PART C POLICY FEATURES, BENEFITS AND PREMIUM PAYMENT

1. **BENEFITS**

1.1. DEATH BENEFIT

- 1.1.1. If the Policy is in force and is not under Reduced Paid Up Mode, then, upon death of the Life Insured, during the Policy Term, We will pay "Guaranteed Death Benefit" to the Claimant which will be highest of the following:
 - a. <u>For Single Premium Payment Variant</u> 1.25 times of the sum of single Premium and Underwriting Extra Premium, if any; <u>For all other Premium payment variants</u> – 10 times the sum of Annualised Premium and Underwriting Extra Premium, if any; or
 - b. 105% of sum of Total Premiums Paid, Underwriting Extra Premium and loadings for modal premiums, if any, received till the date of death of the Life Insured; or
 - c. "Absolute Amount Assured to be Paid on Death" which shall be the Sum Assured on Death payable as per the Cover Option chosen by You.
- 1.1.2. The Claimant will have the option to choose from one of the following payout options at claims stage. In case no payout option is selected by the Claimant, then the payout option 1 (lump sum Guaranteed Death Benefit) will be considered as the default payout option:
 - a. <u>Payout option 1</u> *lump sum Guaranteed Death Benefit* 100% of the Guaranteed Death Benefit will be paid as lump sum.
 - b. <u>Payout option 2</u> *monthly income* monthly payment for a fixed period of 10 years starting from the next monthly anniversary following the date of intimation of death ("Payout Period") shall be calculated as per the formula below:

Monthly Income =
$$\frac{Guaranteed Death Benefit \times i}{\left(1 - \frac{1}{(1+i)^{120}}\right) \times (1+i)}$$

Where interest ("i") equals to $(1 + (Bank Rate - 1\%))^{1/12} - 1$

For the purpose of the above calculation Bank Rate shall mean the prevailing RBI Bank Rate as declared by the Reserve Bank of India. The monthly income shall be determined basis the prevailing RBI Bank Rate on the date of intimation of death, less 1% p.a. The interest rate will be revised only if the RBI Bank Rate changes by 50 bps or more from the RBI Bank rate used to determine the prevailing interest rate (reviewed on 1st day of every quarter). As the interest rate will be reviewed at the beginning of each quarter, any change in interest rate will be applicable from 1st day of the next quarter to allow sufficient time for making necessary system changes.

c. <u>Payout option 3</u> – *partial Guaranteed Death Benefit plus part monthly income*- If the Claimant chooses this payment option, We will pay the proportion as may be selected by the Claimant of the Guaranteed Death Benefit as lump sum and the remaining Guaranteed Death Benefit would be payable as monthly income.

<u>Note:</u> In case monthly payout option has been selected whether under (b) or (c), above then during the Payout Period, the Claimant may commute the outstanding monthly income. In such case We will pay the present value of the outstanding monthly income at the same interest rate used to determine the monthly income.

1.1.3. In case Terminal Illness Benefit claim has been paid, then the Guaranteed Death Benefit shall be reduced to the extent of the Terminal Illness Benefit already paid.

1.1.4. **Point of Sale Policy**

In case this Policy is sourced as a point of sale Policy, the following conditions shall apply:

- a. In case of death of the Life Insured, death benefit will be payable as noted in Clause 1.1.1 above. However, in case the Life Insured dies during the waiting period of 90 days from Date of Commencement of Risk due to any reason other than an Accident, We will refund 100% of the Total Premiums Paid till the date of death of the Life Insured and no other benefit will be payable and the Policy will terminate.
- b. In the event of death of Life Insured due to an Accident, the waiting period of 90 days as specified above shall not be applicable and the death benefit shall be payable in accordance with Clause 1.1.1.

1.2. TERMINAL ILLNESS BENEFIT

- 1.2.1. If the Policy is in force and is not under Reduced Paid Up Mode, then, upon Diagnosis of Life Insured with a Terminal Illness, during the Policy Term, We will pay 100% of the Guaranteed Death Benefit (subject to maximum of Rs. 1 Crore) as accelerated Terminal Illness Benefit to the Claimant. Only one valid Terminal Illness Benefit is payable during the Policy Term and once a Terminal Illness claim is paid, the sum of Guaranteed Death Benefit and Voluntary Sum Assured Top-Up, if opted, will be reduced by the Terminal Illness Benefit paid and the Policy will continue.
- 1.2.2. The Terminal Illness Benefit does not provide additional benefit but only accelerates the Guaranteed Death Benefit payable under this Policy, subject to maximum of Rs. 1 Crore.
- 1.2.3. The claim payout under the Terminal Illness Benefit would be made in lump sum only. The Claimant shall not have the options to receive or convert the lump sum claim amount into monthly income



- 1.2.4. In case the claim against the Terminal Illness has been raised, We may request the Life Insured to undertake a medical examination or test at Our cost, which in Our opinion, is reasonable to determine the Terminal Illness. We shall not accept a claim if the Member does not undertake any medical examination or test which We consider reasonable or necessary to determine the Terminal Illness.
- 1.2.5. After the payment of the claim in respect of Terminal Illness of the Life Insured, all Premiums (including the Premium for base Policy and optional benefits i.e. Premium Break Option, Joint Life Cover Option and/or Voluntary Sum Assured Top-Up Option) falling due from the date of Diagnosis of Terminal Illness would be waived off and the Policy shall continue till death of the Life Insured or the end of the Policy Term, whichever is earlier. However, in case You have opted for Joint Life Cover Option and the Secondary Life survives on the date of Diagnosis of Terminal Illness of the Life Insured then the Policy will continue till Death or Diagnosis of Terminal illness of the Secondary Life or end of the Policy Term, whichever is earlier.
- 1.2.6. Accidental Death benefit shall terminate post Diagnosis of Terminal Illness. Post the Diagnosis of Terminal Illness of the Life Insured, You are allowed to surrender the Policy in accordance with Clause 1 of Part D.
- 1.2.7. Terminal Illness Benefit will be available in case of Policy is sourced as a point of sale policy.

1.3. ACCIDENTAL DEATH BENEFIT

- 1.3.1. In case the Accidental Death benefit option is chosen, subject to the Policy being in force and the Life Insured dies due to an Accident, 100% of Accidental Death Benefit Sum Assured will be payable as lump sum irrespective of the Cover Option chosen by You, whereupon the Accidental Death benefit option will terminate and no further benefit shall be paid under this Accidental Death benefit option. In a scenario where Accident happened during the Accidental Death Benefit Term and death due to the same Accident happens after the Accidental Death Benefit Term, but within 180 days from the date of the Accident, the Accidental Death Benefit Sum Assured shall be payable.
- 1.3.2. You may choose to opt for an Accidental Death benefit option at the Date of Inception of Policy or at any point of time during the Policy Term, subject to the Policy being Premium paying and remaining Policy Term being more than 5 (Five Years), subject to our Underwriting Policy. A pro-rata basis additional Premium for the Accidental Death benefit option will be charged in case the benefit is added during the middle of a Policy Year and full Premium for the Accidental Death benefit option will be charged starting from next Policy Anniversary. However, in case Premium Break Option has been selected then Accidental Death benefit option cannot be chosen after the Date of Commencement of Risk.
- 1.3.3. Maximum Accidental Death Benefit Sum Assured available under Accidental Death benefit option is Rs. 1 Cr, however in no case shall the Accidental Death Sum Assured be higher than three times Guaranteed Death Benefit prevailing at the time of opting for the Accidental Death benefit cover.
- 1.3.4. You may at any time during the Policy Term choose to opt out of/discontinue the Accidental Death benefit option, upon which, the total Premium to be paid will be reduced by the Accidental Death benefit Premium and only the Premium corresponding to the death benefit or Riders/optional benefits (if any) will continued to be payable. It is clarified that, once Accidental Death benefit option is discontinued, the benefit cannot be again opted for.
- 1.3.5. The Accidental Death benefit option is not available under Single Premium Payment Variant.
- 1.3.6. The Accidental Death benefit will always be paid as a lump sum benefit.
- 1.3.7. This benefit shall be available under any point of sale Policy only when the Policyholder has selected this Accidental Death benefit option.
- 1.3.8. **Termination of Accidental Death benefit option**: The Accidental Death benefit option will terminate immediately upon the occurrence of any of the following events, whichever is earliest:
 - a) On the expiry of the Accidental Death Benefit Term;
 - b) On payment of 100% of the Accidental Death Benefit Sum Assured;
 - c) On cancellation or surrender of the Policy;
 - d) On death of the Life Insured;
 - e) Life Insured being diagnosed with Terminal Illness;
 - f) On Your failure to revive the Policy within the Revival Period of the Policy; or;
 - g) You opting out of or discontinuing the Accidental Death benefit option.
- 1.3.9. Exclusions applicable to Accidental Death benefit: In case the death of the Life Insured has occurred directly or indirectly due to or caused, occasioned, accelerated or aggravated by any of the following, no Accidental Death benefit shall be payable:a) Suicide or self-inflicted Injury, whether the Life Insured is medically sane or insane.
 - b) War, terrorism, invasion, act of foreign enemy, hostilities, civil war, martial law, rebellion, revolution, insurrection, military
 - or usurper power, riot or civil commotion. War means any war whether declared or not.
 - c) Taking part in any naval, military or air force operation during peace time.
 - d) Any condition that is pre-existing at the time of later of Date of Commencement of Risk or Date of Inception of Policy
 - e) Committing an assault, a criminal offence, an illegal activity or any breach of law with criminal intent.f) Alcohol or solvent abuse or taking of drugs, narcotics or psychotropic substances unless taken in accordance with the lawful
 - directions and prescription of a Medical Practitionerg) Poison, gas or fumes (voluntary or involuntarily, accidentally or otherwise taken, administered, absorbed or inhaled).
 - h) Service in the armed forces, or any police organization, of any country at war or service in any force of an international body
 - Participation in aviation other than as a fare-paying passenger in an aircraft that is authorised by the relevant regulations to carry such passengers between established aerodromes.
 - j) Taking part in professional sport(s) or any adventurous pursuits or hobbies including any kind of racing (other than on foot or swimming), potholing, rock climbing (except on man-made walls), hunting, mountaineering or climbing requiring the use of ropes or guides, any underwater activities involving the use of underwater breathing apparatus including deep sea diving, sky diving, cliff diving, bungee jumping, paragliding, hand gliding and parachuting.



k) Nuclear contamination; the radioactive, explosive or hazardous nature of nuclear fuel materials or property contaminated by nuclear fuel materials or Accident arising from such nature.

1.4. MATURITY BENEFIT

No Maturity Benefit is payable except where Return of Premium Option has been chosen by You at Date of Inception of Policy. This option cannot be selected at later stage during the Policy Term. Under this option, if the Life Insured survives throughout the Policy Term, 100% of the sum of Total Premiums Paid, Underwriting Extra Premiums and loadings for modal premiums received under the Policy (corresponding to the Guaranteed Death Benefit and any Voluntary Top Sum Assured) will be paid to You, on maturity ("**Return of Premium Option**"). Additional premium charged for optional benefits such as Accidental Death benefit option, Secondary Life benefit under Joint Life Cover or towards Riders, if any, will not be returned on maturity under the Return of Premium Option. If there is a discount applicable under the Policy, only 100% of the discounted Premiums received (corresponding to the Guaranteed Death Benefit and any Voluntary Top Sum Assured) under the Policy would be returned on maturity of the Policy. It is clarified that in case You have opted for the Joint Life Cover Option the Maturity Benefit will be paid only if the Life Insured is alive on the Maturity Date, irrespective of the Secondary Life being alive or not.

1.5. VOLUNTARY SUM ASSURED TOP-UP

- 1.5.1. Post completion of waiting period of 1 year from the Date of Commencement of Risk and subject to receipt of Your written request and medical and financial underwriting by Us, We may allow You to increase the Sum Assured on Death on Premium which will be determined by Us basis the Age of the Life Insured at the time of exercising Voluntary Sum Assured Top-Up Option, once during the Policy. Such increase in the Sum Assured on Death shall in no case exceed 100% of the Sum Assured on Death as on the Date of Commencement of Risk. Once this Voluntary Sum Assured Top-Up Option is exercised, it shall remain level throughout the remaining Policy Term. The Sum Assured on Death can be increased in multiples of Rs.10 lakh only.
- 1.5.2. The Voluntary Sum Assured Top-Up Option can be exercised only if the Policy is in force and the following conditions are satisfied:
 - a) the Age of the Life Insured does not exceed 50 years;
 - b) Increasing Cover Option or Premium Break Option have not been opted;
 - c) The Sum Assured on Death under the Policy as chosen at Date of Inception of Policy, is equal to or greater than Rs.50 Lacs; and
 - d) The minimum Premium Payment Term & Policy Term under for this option are 5 years and 10 years respectively.
- 1.5.3. In case of death of the Life Insured, the Top Up Sum Assured shall be payable alongwith the Guaranteed Death Benefit as per Clause 1.1 of Part C.
- 1.5.4. In case the Life Insured is Diagnosed with Terminal Illness, the Top Up Sum Assured shall be payable along with the Terminal Illness Benefit as per Clause 1.2 of Part C subject to total benefit payable not exceeding Rs.1 Crore.
- 1.5.5. Voluntary Sum Assured Top-Up Option will not be allowed if Premium Break Option has been opted for.
- 1.5.6. Voluntary Sum Assured Top-Up will not impact the Accidental Death Benefit Sum Assured, if opted for.
- 1.5.7. For a Joint Life Cover Option, Voluntary Sum Assured Top-Up Option will be applicable only for You i.e. top-up will not be allowed on Secondary Life.
- 1.5.8. You shall be allowed to surrender the Top-Up Sum Assured anytime as per Your convenience. The Surrender Value shall be different for each Sum Assured on Death and Top-Up Sum assured which shall be determined basis the duration elapsed since the commencement of first Premium payment for each Sum Assured on Death.
- 1.5.9. Return of Premium Option at maturity shall also be available for the Premium paid to enhance the Sum Assured on Death under this Voluntary Sum Assured Top-Up Option.
- 1.5.10. The Voluntary Sum Assured Top-Up Option shall be identical to the base plan variant. i.e. If You have chosen Return of Premium Option, the same shall also apply to Premium paid towards Voluntary Sum Assured Top-Up Option. However, if You have not chosen Return of Premium Option at Date of Inception of Policy, then the same cannot be applied to Premium paid toward Voluntary Sum Assured Top-Up Option.
- 1.5.11. The Premium rates for Voluntary Sum Assured Top-Up Option will be determined basis the Sum Assured on Death band of the Policy applicable to the Sum Assured on Death inclusive of the Voluntary Sum Assured Top-Up.
- 1.5.12. The minimum outstanding base Policy Term to exercise this option is 10 years, subject to the other boundary condition of maximum attained Age.
- 1.5.13. The Policy Term of this option shall be same as the outstanding Policy Term of the base Policy cover and the Premium Payment Term shall be the maximum Premium Payment Term available at the time of opting for this option but not exceeding the base cover Premium Payment Term.
- 1.5.14. Waiver of Premium Plus Rider will also be applicable for Voluntary Sum Assured Top-Up i.e. if You have opted for Waiver of Premium Plus rider and later exercise the Voluntary Sum Assured Top-Up then Waiver of Premium Plus Rider benefit would be payable for the additional Premium corresponding to the Voluntary Sum Assured Top-Up.
- 1.5.15. Voluntary Sum Assured Top-Up will not be available in case of Policy is sourced as a point of sale policy.

1.6. JOINT LIFE COVER OPTION

- 1.6.1. If You have opted for Joint Life Cover Option at Date of Inception of Policy, to cover Your spouse (**"Secondary Life"**) under this Policy, then in case of either death or Diagnosis with Terminal Illness of the Secondary Life:
 - i. Before the death or Diagnosis with Terminal Illness of Life Insured, then, We will pay an amount of Rs. 10 (Ten) lacs to You as guaranteed death benefit and cover on the life of the Secondary Life will end, however the cover of life of the Life Insured continues with Premium reduced to the extent to the Premium payable with respect to Joint Life Cover Option and with applicable Guaranteed Death Benefit.
 - ii. After the death or Diagnosis with Terminal Illness of Life Insured, We will pay an amount of Rs.50 (Fifty) lacs to the Claimant as guaranteed death benefit.



- 1.6.2. Premium payable under the Policy with respect to Joint Life Cover Option including applicable of loadings for modal premiums and taxes) will be waived off when the Life Insured dies or is Diagnosed with Terminal Illness, whichever is earlier.
- 1.6.3. Joint Life Cover Option will be available only where You have taken the Policy on your own life and the Guaranteed Death Benefit under the Policy is greater than or equal to Rs.1 Crore.
- 1.6.4. Maximum Age at maturity of Secondary Life cannot be more than 85 years, accordingly the Joint Life Cover Option for Secondary Life will automatically terminate on the Policy Anniversary immediately following his/her 85th birthday irrespective of the cover in respect of Life Insured still being in force.
- 1.6.5. In case You have chosen Increasing Cover Option, the Guaranteed Death Benefit only in respect of the Life Insured shall increase and it will not impact the life cover towards Secondary Life. Further all other optional benefits under this Policy including Accidental Death benefit cover, Voluntary Sum Assured Top-Up Option and available Riders shall applicable only on the life cover provided to the Life Insured and will not available for Secondary Life.
- 1.6.6. In the event of simultaneous death or Diagnosis of Terminal Illness of both the Life Insured and Secondary Life or death of Life Insured and Diagnosis of Terminal Illness of Secondary Life or vice versa, an amount of Rs.50,00,000 will be paid to the Claimant towards Secondary Life in addition to the Guaranteed Death Benefit payable in respect of the Life Insured.
- 1.6.7. In the earlier event of death of the Life Insured prior to Secondary Life, the Secondary Life will become the policyholder under the Policy.
- 1.6.8. The benefits under this Joint Life Cover Option can be surrendered by You anytime during the Policy Term. However, the Secondary Life cannot surrender benefits under this Joint Life Cover Option or the Policy upon the death of the Life Insured.
- 1.6.9. In case of death of Secondary Life due to suicide within 12 months from the Date of Commencement of Risk or Date of Inception of Policy or the date of Revival of the Policy, whichever is later, provisions as per Clause 6 of Part F will be applicable and Secondary Life benefit will terminate. Cover for Life Insured will continue with reduced Premium along with the other additional options like Accidental Death benefit cover, Voluntary Sum Assured Top-Up Option and available Riders, if any.
- 1.6.10. Joint Life Cover Option will not be available in case of Policy is sourced as a point of sale policy

1.7. PREMIUM BREAK OPTION

- 1.7.1. You shall be allowed to opt for the Premium Break Option on payment of extra Premium on the Date of Inception of Policy only. Once opted for, You are allowed to take two annual Premium breaks (or its equivalent as per Clause 1.7.4 of Part C) from paying the Premiums under the Policy after completion of 10 Policy Years provided all due Premiums have been paid ("Premium Break"). The duration of one Premium Break shall be 12 Policy months and the Premium which shall be waived shall include the Premium to be paid towards base Policy cover and Accidental Death benefit Premium inclusive of Underwriting Extra Premium, loadings for modal premiums, if any, and any applicable taxes thereon. The second Premium Break can be exercised only after a minimum gap of 10 years from end of the first Premium Break period.
- 1.7.2. During the Premium Break, the Policy will remain in force with the full risk cover as per terms and condition of the Policy.
- 1.7.3. This Premium Break Option is available only if you have opted for Regular Premium Payment Variant or Pay Till 60 Premium Payment Variant and where the Policy Term is greater than 30 years and Premium Payment Term greater than 21 years.
- 1.7.4. Once the Premium Break Option is in force, it shall continue for 12 consecutive Policy months i.e. one Premium Break shall mean 1 annual Premium or 2 half-yearly Premiums or 4 quarterly Premium or 12 monthly Premiums.
- 1.7.5. This Premium Break Option can be exercised from the next Premium anniversary, independent of the Policy Anniversary. For example, for a monthly mode Policy, a You after having paid 125 monthly premiums may choose not to pay the next monthly Premium upto a maximum of 12 month Premiums.
- 1.7.6. If You have exercised the first Premium Break in the last 10 years of the Policy, then the second Premium Break shall be by default the last Policy Year Premium as applicable.
- 1.7.7. In case You do not voluntarily exercise the Premium Break benefit during the Premium Payment Term, We will waive off the last two Policy Year Premiums (last Policy Year Premium if partly exercised earlier) as applicable.
- 1.7.8. For exercising a Premium Break Option, You will be required to intimate Us, at least 30 days (15 days in case of Premium payment mode is monthly) before next Premium due date. Thus if a Premium is unpaid with no prior intimation, then at the end of the Grace Period the Policy shall become Lapsed Policy / Reduced Paid Up, as the case may be.
- 1.7.9. If You discontinue Premium payment immediately post exercising one or both the Premium Break, the Revival Period will be considered to start from the due date of Premium payable after the end of the Premium Break period.
- 1.7.10. You cannot opt for Premium Break Option if You have chosen Joint Life Cover option.
- 1.7.11. If Premium Break Option has been opted for then Accidental Death benefit can only be opted at Date of Inception of Policy and not later in the Policy Term.
- 1.7.12. Voluntary Sum Assured Top-Up option is not available with Premium Break Option.
- 1.7.13. No Rider will be available with Premium Break Option.
- 1.7.14. You can surrender the Policy anytime along with this option even during the Premium Break period, however, the surrender can be done along with the base Policy only and not separately.
- 1.7.15. Premium Break Option will only be applicable on the base Policy Premium (including Return of Premium Option) and Accidental Death benefit Premium.
- 1.7.16. Premium Break Option will not be available in case of Policy is sourced as a point of sale policy.

1.8. REDUCED PAID-UP BENEFIT/ NON FORFEITURE OPTIONS

If Return of Premium Option was chosen by You at the Date of Inception of Policy and Policy has acquired a Surrender Value as specified under Clause 1 of Part D, then, in the event of non-payment of the due Premiums by You to Us, on the expiry of the Grace Period, this Policy will not become a Lapsed Policy and by default will continue under Reduced Paid-Up Mode unless revived. A Reduced Paid-Up Policy can be revived within a Revival Period, subject to conditions, for revival of Lapsed Policy mentioned in Part D. If a Reduced Paid-Up Mode Policy is not revived within Revival Period, then the Policy cannot be revived and the Policy will continue as Reduced Paid-Up Policy for the remaining Policy Term.



Policy under the Reduced Paid-Up Mode will be free from all liabilities of payment of future Premiums to Us. If this Policy is under Reduced Paid-Up Mode, then, the benefits payable shall be as follows:

1.8.1. Reduced Paid – Up Death Benefit

a. In the event of the death of the Life Insured during Policy Term when the Policy is under Reduced Paid-Up Mode, the death benefit, in case of Level Cover Option, will be reduced as per the below formula:

Reduced Paid-Up Sum Assured= ((Total Premium Paid under base Policy) / (total Premiums payable under base Policy (excluding Underwriting Extra Premium, loadings for modal premiums and Rider Premium, if any)) * Sum Assured on Death applicable before Policy moved to Reduced Paid-Up Mode.

b. In case of the Increasing Cover Option, the future increase in Reduced Paid-Up death benefit post the Policy becomes Reduced Paid-Up will also get reduced as per the below proportionate Premiums formula:

5% * Sum Assured on Death at the Date of Inception of Policy * ((Total Premium Paid under base Policy) / (total Premiums payable under base Policy (excluding Underwriting Extra Premium, loadings for modal premiums and Rider Premium, if any))

c. It is clarified that for the purpose of above calculations Total Premium Paid towards base death benefit would only be considered.

1.8.2. Reduced Paid – Up Terminal Illness Benefit

In the event the Life Insured is Diagnosed with a Terminal Illness during Policy Term, when the Policy is under Reduced Paid-Up Mode, a benefit equal to the Reduced Paid-Up Mode death benefit as noted in Clause 1.8.1 of Part C, subject to a maximum limit of Rs.1 Crore shall be payable. Upon payment of Reduced Paid-Up Terminal Illness Benefit, the Reduced Paid-Up Death Benefit will be reduced by the amount of the benefit paid.

1.8.3. Reduced Paid – Up Maturity Benefit

Under the Return of Premium Option, if the Life Insured has survived until the Maturity Date, 100% of the Sum of Total Premiums Paid, Underwriting Extra Premium and loadings for modal premiums, if any (corresponding to base Policy cover, Premium Break Option and Voluntary Sum Assured Top-Up Option) will be paid at end of Policy Term. Please note that any additional Premium charged for optional benefits (Accidental Death benefit cover option and Joint Life Cover) or Riders, will not be returned back at maturity under this option.

1.8.4. Reduced Paid – Up Surrender Value

The Surrender Value of Reduced Paid-Up Policy will be as calculated in accordance with Clause 1 of Part D (Surrender / Early Exit Value). The Policy which has acquired the Surrender Value shall lapse if the reduced paid up sum insured under the Policy is less than Rs. 2500/-. In case the reduced paid up sum assured on Death of the Policy is less than Rs. 2500/, the Policy may be terminated after expiry of Revival Period by paying the applicable Surrender Value.

1.8.5. No benefit will be paid towards Accidental Death benefit cover or Secondary Life (in case Joint life Cover Option has been opted) once the Policy has moved into Reduced Paid Up mode.

2. PREMIUMS

- 2.1. You shall have a choice between the Single Premium Payment Variant, Limited Premium Payment Variant, Regular Premium Payment Variant or Pay Till 60 Premium Payment Variant for Premium payments. Unless otherwise allowed in the Policy, the Premium payment variant can only be chosen at the Date of Inception of Policy and cannot be changed subsequently. The Premium payment mode for Accidental Death benefit cover and Voluntary Sum Assured Top-Up Option shall be same as base Policy Premium payment mode.
- 2.2. You can pay the Premium annually, semi-annually, quarterly or on monthly basis, as per the Premium payment mode chosen by You. However, Premium payment mode applicable for base cover will be applicable Premium payable towards any optional benefits/ Riders that You may have opted under this Policy.
- 2.3. You have an option to change the Premium payment mode during the Premium Payment Term by submitting a written request to Us. Any change in the Premium payment mode will result in a change in the Premium amount basis the applicable Modal Factors. A change in Premium payment mode will be effective only on the modal Anniversary following the receipt of such request, depending on the premium payment frequency chosen by You.
- 2.4. You can pay Premium at any of Our offices or through Our website <u>www.axismaxlife.com</u> or by any other means, as informed by Us. Any Premium paid by You will be deemed to have been received by Us only after the same has been realized and credited to Our bank account.
- 2.5. The Premium payment receipt will be issued in Your name, which will be subject to realization of cheque or any other instrument/medium.
- 2.6. Premium rates for the death benefit and Accidental Death benefit cover option are guaranteed for the entire Policy Term.
- 2.7. Under Accidental Death benefit cover, the Premium Payment Term and Accidental Death Benefit Term will be subject to the remaining Premium Payment Term and Policy Term of the base Policy benefit, such that:
 - 1) At Date of Inception of Policy, the Accidental Death Benefit Term and Premium Payment Term shall be same as that of the base Policy.
 - 2) Post the Date of Inception of Policy, the Accidental Death Benefit Term shall be same as the remaining Premium Payment Term of the base Policy benefit. The Accidental Death Benefit Term shall be the maximum Premium Payment Term available under Accidental Death benefit cover at the time of opting for this option but not exceeding the base Policy Premium Payment Term.



3. GRACE PERIOD

- 3.1. The Premium is due and payable by the due date specified in the Schedule. If the Premium is not paid by the due date, You may pay the same during the Grace Period without any penalty or late fee.
- 3.2. The insurance coverage continues during the Grace Period. However, if the overdue Premium is not paid even in the Grace Period and the Life Insured dies, then, We will pay the death benefit after deducting the unpaid premium (if any) till date of death.



PART D

POLICY SERVICING CONDITIONS

1. SURRENDER/ EARLY EXIT VALUE

You may surrender the Policy any time after the Policy has acquired a Surrender Value or Early Exit Value as below:

1.1 If You have not opted for Return of Premium Option:

- 1.1.1. The Policy shall acquire Early Exit Value ("Early Exit Value"), subject to the following criteria:
 - a. For Single Premium Payment Variant: immediately after payment of single Premium.
 - b. For Limited Premium Payment Variant including Pay Till 60 Variant: Upon completion of Premium Payment Term on receipt of all due Premiums.
 - c. Regular Premium Payment Variant: No surrender benefit is applicable or payable.
 - The Early Exit Value shall be determined basis the formula provided below:

70% x (Sum of Total Premium Paid, Underwriting Extra Premium and loadings for modal premiums, if any) x (unexpired Policy Term/Policy Term).

- 1.1.2. <u>Special Exit Value</u>: You shall be allowed a Special Exit Value, wherein We will return sum of Total Premiums Paid, Underwriting Extra Premiums and loadings for modal premiums, if any, only if You surrender the Policy during:
 - For Policy with Policy Term between 40-44 years: 25th Policy Year or during the period when the attained Age of the Life Insured is between 65th and 66th Year, whichever is earlier,
 - For Policy with Policy Term greater than 44 years: 30th Policy Year or during the period when the attained Age of the Life Insured is between 65th and 66th Year, whichever is earlier.

The following conditions shall be applicable for Special Exit Value:

- (i) The Policy has to be in force at the time of availing this Special Exit Value.
- (ii) The Policy shall be terminated after availing this Special Exit Value.
- (iii) Special Exit Value shall not be available with Policy with Return of Premium Option.
- (iv) Special Exit Value shall not be available for Policy Term less than 40 years.
- (v) Special Exit Value shall be applicable on the base Policy Premium only and not to additional optional benefits like Accidental Death benefit, Joint life cover or Voluntary Sum Assured Top-Up.
- 1.1.3. For optional benefits like Accidental Death benefit cover, Joint Life Cover Option, Premium Break Option or Voluntary Sum Assured Top-Up Option, Early Exit Value will be payable.

1.2 If You have opted for Return of Premium Option and You discontinue paying Premium or You surrenders the Policy, then:

- 1.2.1 The Policy shall acquire Guaranteed Surrender Value ("Surrender Value"), subject to the following criteria:
 - a) For Single Premium Payment Variant: immediately after payment of single Premium.
 - b) Limited Premium Payment Variant including Pay Till 60 Premium Payment Variant and Regular Premium Payment Variant: on receipt of two full year Premium.
- 1.2.2 The Surrender Value is the higher of Guaranteed Surrender Value or Special Surrender Value. Guaranteed Surrender Value is defined as:

Guaranteed Surrender Value factor x (sum of Total Premium Paid, Underwriting Extra Premium and loadings for modal premiums, if any)

The Guaranteed Surrender Value factors are provided below:

1.2.3 Surrender Value for the Premium paid towards Premium Break and Voluntary Sum Assured Top Up Option will be calculated in the same manner as for the Premium paid towards base cover under this Policy. However, no Surrender Value will be paid in lieu of the Premium paid towards Accidental Death benefit cover and Joint Life Cover Option.



1.3 Special Surrender Value

- 1.3.1Your Policy also acquires a Special Surrender Value after completion of first Policy Year provided one full year Premium has been received and shall become payable after completion of first Policy Year for Limited Premium Payment Variant/ Regular Premium Payment Variant. For Single Premium Payment Variant, Your Policy shall acquire a Special Surrender Value immediately upon receipt of Single Premium. Before making a request for Surrender, You may approach Us to know about the Surrender Value in respect of Your Policy.
- 1.3.2 It may be noted that the Special Surrender Value and the basis for calculating the Special Surrender Value factors under the Policy may be revised by Us based on the experience or applicable laws.
- 1.3.3 For Limited Premium Payment Variant/Regular Premium Payment Variant; Surrender requests can only be made after completion of first Policy Year and Special Surrender Value as calculated above shall become payable only after completion of first Policy Year provided one full year Premium has been received.
- 1.3.4 For Single Premium Payment Variant; Special Surrender Value shall become payable immediately after receipt of single Premium.

2. LOANS

- 2.1. If You have opted for Return of Premium Option and once this Policy has acquired the Surrender Value, then, You will be eligible for grant of loans from Us.
- 2.2. The minimum amount of loan which can be granted by Us under this Policy is INR 10,000 (Rupees Ten Thousand). In no event shall the maximum amount of loan which can be granted under this Policy during the Policy Term exceed 75% (Seventy-Five percent) of the Surrender Value payable under this Policy, subject to such terms and conditions as may be determined by Us from time to time.
- 2.3. Upon grant of a loan under this Policy, this Policy shall automatically be assigned in Our favour, till the time the entire loan amount including interest, any fees or dues towards such loan has been repaid to Us. On repayment of the entire loan and accumulated interest to Us, if any, this Policy will be reassigned to You.
- 2.4. If You have obtained a loan under this Policy, then, You are required to pay interest on such loan. The interest on the loan will be compounded and applied annually on the Policy Anniversary at the rates as prescribed by Us at the time of taking the loan.
- 2.5. The loan interest rate shall be equal to applicable 'RBI Bank Rate' plus 3.0%. The current loan interest rate is 9.75% p.a. compounded annually and is based on 'RBI Bank Rate' of 6.75% p.a. prevailing as at 31st March 2024. The 'RBI Bank Rate' for the financial year ending 31st March (every year) will be considered for determining the loan interest rate and the same shall be made effective w.e.f. 01st July every year. The loan interest rate is revised only if the 'RBI Bank Rate' changes by 1% or more from the 'RBI Bank Rate' used to determine the prevailing loan interest rate (reviewed on every 31st March). For further details and the loan interest rate applicable as on date, please refer to our website <u>www.axismaxlife.com</u>. Any change in the basis of determination of the above interest rate shall be with prior approval of IRDAI.
- 2.6. We reserve the right to recover the any outstanding loan along with the accrued interest from the benefits payable in the case of Surrender or maturity or death of the Life Insured, by deducting the appropriate amounts from the benefits payable on happening of such events.
- 2.7. The inforce polices or fully paid up polices will not be foreclosed for non-payment of outstanding loan balance even if the outstanding loan balance and accumulated interest on such loan exceeds the Surrender Value.
- 2.8. For Reduced Paid Up Mode policies, if the outstanding loan amount granted to You and accumulated interest on such loan exceed the Surrender Value, the Policy will terminate. In case outstanding loan amount including accumulated interest on such loan exceeds 95% of the Surrender Value or the remaining Policy Term is 6 months (whichever is earlier), We will send You a communication for repayment of loan along with the accrued interest.
- 2.9. If You have not opted for Return of Premium Option, You are not entitled to any loans under this Policy.

3. REVIVAL OF POLICY

A Lapsed Policy can be revived as per Our Underwriting Policy, within the Revival Period:

- 1.1 on receipt of Your written request to revive the Policy by Us; and
- 1.2 if You produce an evidence of insurability (in form of declaration of health condition and/or relevant medical reports) of Life Insured at Your own cost which is acceptable to Us; and
- 1.3 on payment of all overdue Premiums (along with the applicable taxes, cesses and levies, if any) to Us with interest fee as may be determined by Us from time to time (in the manner described herein below) as on the date of Revival. Currently the applicable late fee is as below:

The 'RBI Bank Rate' for the financial year ending 31st March (every year) will be considered for determining the revival interest rate and the same shall be made effective w.e.f. 01st July every year. The revival interest rate is revised only if the 'RBI Bank Rate' changes by 1% or more from the 'RBI Bank Rate' used to determine the prevailing revival interest rate (reviewed on every 31st March). For further details and the Revival interest rate applicable as on date, please refer to our website <u>www.axismaxlife.com</u>. Any change in methodology to derive the Revival rate of interest shall be with prior approval from IRDAI.

- 1.4 The Revival of the Lapsed Policy will take effect only after We have approved the same in accordance with Our Underwriting Policy and communicated Our decision to You in writing. All benefits including death and monthly income which were originally payable will be restored on such Revival with effect from due date of the unpaid Premium.
- 1.5 If a Lapsed Policy is not revived within the Revival Period, this Policy will terminate without value, on the expiry of the Revival Period.
- 1.6 The Policy cannot be revived beyond the Policy Term.
- 1.7 Once the Policy has acquired Surrender/ Early Exit Value, if future Premiums are discontinued then the Policy shall not lapse and the following shall be applicable:
 - a. <u>Under Return of Premium Option</u>: The Policy will by default become Reduced Paid-Up Policy. A Reduced Paid-Up Policy can be revived within the Revival Period, subject to conditions mentioned above for Revival of Lapsed Policy. If a Reduced Paid-Up Policy is not revived within the Revival Period, then the Policy cannot be revived and will continue as Reduced Paid-Up Policy for the rest of its Policy Term.
 - b. <u>Other than the Return of Premium Option</u>: If the Policy is not revived within a Revival Period from the due date of first unpaid Premium, an Early Exit Value shall be paid to the You and the Policy shall be terminated.
- 1.8 In case of non-receipt of Premium, the cover for Accidental Death benefit and Joint Life Cover Option will lapse and no benefits shall be payable. However, the cover for these benefit options can be reinstated during the Revival Period as per the applicable terms and conditions for Revival of Policy.
- 1.9 Once the Policy has been revived, all the benefits will get reinstated to original levels, which would have been the case had the Policy remained premium paying including the optional benefits chosen.
- 1.10 In addition to the revival provisions stated above and subject to Our sole discretion, You may also be eligible to avail of one or more of the following revival schemes to revive Your Policy:
 - i. Reduction in the Sum Assured on Death: You may be eligible to revive your Policy by reducing the Sum Assured on Death. Please contact Us for details on whether You are eligible for this Revival scheme and, if so, the extent to which the Sum Assured on Death can be reduced, the total amount required to be paid by You to revive the Policy and the applicable terms and conditions for utilizing this revival scheme;
 - ii. Change in the Premium Payment Term: You may be eligible to revive your Policy by changing the Premium Payment Term. Please contact Us for details on whether You are eligible for this revival scheme and if so, the extent to which the Premium Payment Term can be changed, the total amount required to be paid by You to revive the Policy and the applicable terms and conditions for utilizing this revival scheme;
 - iii. Special Revival Schemes: We may also introduce special revival schemes from time to time which are available for a particular period. Please contact Us for details on whether such revival scheme is available and, if You are eligible for the same, the total amount required to be paid by You to revive the Policy and the applicable terms and conditions for utilizing such revival scheme.
 - iv. We may, from time to time, at Our sole discretion, introduce new revival schemes or modify or terminate existing revival schemes. Please contact Us for details on 1860 120 5577 or visit Our website <u>www.axismaxlife.com</u>.

4. PAYMENT OF BENEFITS

- 4.1. The benefits under this Policy will be payable only on submission of satisfactory proof to Us. The benefits under this Policy will be payable to the Claimant.
- 4.2. Once the benefits under this Policy are paid to the Claimant, the same will constitute a valid discharge of Our liability under this Policy.

5. TERMINATION OF POLICY

- This Policy will terminate upon the happening of any of the following events:
- 5.1. on the date on which We receive Freelook cancellation request from You;
- 5.2. the date of death of the Life Insured or Secondary Life, whichever is later;
- 5.3. upon payment of the Sum Assured on Death or 100% of the Guaranteed Death Benefit to Claimant;
- 5.4. on the expiry of the Revival Period, if the Lapsed Policy has not been revived;
- 5.5. on the date of payment of Surrender Value as per the terms and conditions of the Policy;
- 5.6. on the Maturity Date, upon the payment of the all Maturity Benefits, if any;
- 5.7. upon payment of the commuted value of the future benefits; or
- 5.8. upon payment of dues as per suicide clause (Clause 6 of Part-F);

6. FREELOOK CANCELLATION

"Free look" means a period of 30 days beginning from the date of receipt of the Policy, to review the terms and conditions of the Policy. If You disagree with the any of the Policy terms and conditions or otherwise, You have the option to cancel the Policy by sending a written request to Us, stating the reasons for Your objection. Upon receipt of Your request, if no claim has been made under the Policy, the Policy will terminate immediately and all rights, benefits and interests under the Policy will cease immediately. You shall be entitled to a refund of the Premium received by Us after deducting the proportionate risk Premium for the period of cover, charges of stamp duty paid and the expenses incurred by Us on medical examination of the Life Insured, if any irrespective of the reasons mentioned.



7. LAPSATION OF POLICY

In case of Lapsed Policy risk cover will cease and no benefits shall be payable. Once the Policy has acquired Surrender Value / Early Exit Value, the Policy shall not lapse at the end of the Grace period. You may revive a Lapsed Policy during the Revival Period.



PART E <u>POLICY CHARGES</u>

APPLICABLE FEES/ CHARGES UNDER THE POLICY

This Policy is a non-linked non participating individual pure risk life insurance plan and therefore, Part E is not applicable to this Policy.



PART F GENERAL TERMS AND CONDITIONS

1. ELIGIBILITY

- 1.1. The minimum Age of the Life Insured on the Date of Commencement of Risk should be 18 (Eighteen) years.
- 1.2. The maximum Age of the Life Insured on the Date of Commencement of Risk should be:
 - 1.2.1. For Single Premium Payment Variant, Regular Premium Payment Variant, Limited Premium Payment Variant 65 (Sixty-Five) years (except in case of the policies sourced through point of sales person it will be 55 (Fifty-Five) years; and;
 - 1.2.2. For Pay Till 60 Premium Payment Variant 44 (Forty-Four) years.
 - 1.2.3. For Voluntary Sum Assured Top-Up Option 50 (Fifty) years.
- 1.3. The maximum Age of the Life Insured on the Maturity Date cannot exceed:
 - 1.3.1. For Death/ Terminal Illness Benefit and Accidental Death benefit option is 85 (Eighty-Five) years.
 - 1.3.2. For policies sourced through point of sales person is 65 (Sixty-Five) years.

In case the Return of Premium Option has been chosen by You, maximum Policy Term for base death benefit and Accidental Death benefit option shall in no case exceed 50 Years from the Date of Commencement of Risk.

2. TAXES

- 2.1. All Premiums received, benefits payable, and/or funds accumulated under the Policy or as may be maintained by Us for policyholders are subject to applicable taxes, cesses, and levies, including but not limited to Goods and Services Tax (GST) and Income Tax, as applicable, which shall be entirely borne by You and will always be paid by You at the time of Premium payment, receipt of benefits and/or fund payout, as applicable.
- 2.2. Notwithstanding anything contained in this Policy or otherwise, We hereby reserve the right to claim, deduct, reduce and/or setoff a sum equivalent to any tax, interest, penalty, and/or other payments, as maybe imposed by any legislation, regulation, order, judgment, or otherwise, from any benefits payable to You, your nominee, or assignee or from the funds accumulated under the Policy or funds maintained by Us.
- 2.3. Tax benefits may be available as per prevailing tax laws. Tax laws, their interpretation and/or application, including benefits arising thereunder are subject to change. You are advised to consult your tax advisor regarding the tax benefits and liabilities applicable to you.

3. CLAIM PROCEDURE

3.1. For processing a claim request under this Policy, We will require all of the following documents:

- 3.1.1. In case of a Death claim:
 - 3.1.2. claimant's statement in the prescribed form (death claim application form -form A);
 - 3.1.3. original Policy document;
 - 3.1.4. a copy of police complaint/ first information report (in the case of death by accident or unnatural death or suicidal death of the Life Insured);
 - 3.1.5. All medical/ hospital records (including diagnostic records) in case of hospitalisation;
 - 3.1.6. a copy of duly certified post mortem report, autopsy/viscera report and a copy of the final police investigation report /charge sheet (in the case of death by accident or unnatural death or suicidal death of the Life Insured);
 - 3.1.7. original/ attested copy of death certificate issued by the local/municipal authority (only in the case of death of the Life Insured);
 - 3.1.8. discharge summary / indoor case papers in case death happened due to medical reasons in a hospital;
 - 3.1.9. medical booklet / CGHS card details in case of defence and central government personnel;
 - 3.1.10.body transfer certificate / embassy documents / postmortem report whichever applicable in case of death in foreign country;
 - 3.1.11.complete passport copy in case of death in foreign country;
 - 3.1.12.a self-attested copy of identity proof of the Claimant including Nominee(s) bearing their photographs and signatures (only in the case of the death of the Life Insured);
 - 3.1.13. other life / health insurance details with claim history details;
 - 3.1.14.employer certificate with complete leave records (Form E);
 - 3.1.15.ITR for last 3 years / GST certificate in case of self employed;
 - 3.1.16.in case of a medical/natural death of the Life Insured, the attending physician's statement (Form C) and the medical records (admission notes, discharge/death summary, test reports, etc.);
 - 3.1.17.NEFT mandate form attested by bank authorities
 - 3.1.18.Bank details of Claimant;
 - 3.1.19.any other document or information required by Us for assessing and approving the claim request.

3.1.20.In case of claim with towards Terminal Illness:

- a) Claimant's statement in the prescribed form;
- b) a copy of police complaint/ first information report (wherever applicable);
- c) attending physician's statement;
- d) certificate by a Medical Practitioner confirming Diagnosis of Terminal Illness of the Life Insured/ Secondary Life;
- e) All medical/hospital records (including diagnostic records) pertaining to Terminal Illness and treatment.
- f) a self-attested copy of identity proof of the Claimant including Nominee(s), if any, bearing their photographs and signatures; and
- g) any other documents/information required by Us for assessing and approving the claim request. 3.1.21. In case of Maturity claim:
- a) NEFT Form (if not provided earlier)
- b) a cancelled cheque or copy of passbook with pre-printed name and bank account number, for payout through NEFT (if not



- provided earlier)
- c) a self-attested photo ID proof
- 3.2. A Claimant can download the claim request documents from Our website <u>www.axismaxlife.com</u> or can obtain the same from any of Our branches.
- 3.3. Subject to provisions of Section 45 of the Insurance Act 1938 as amended from time to time, We shall pay the benefits under this Policy subject to Our satisfaction:
 - 3.3.1. that the benefits have become payable as per the terms and conditions of this Policy; and
 - 3.3.2. of the bonafides and credentials of the Claimant.
- 3.4. Subject to Our sole discretion and satisfaction, in exceptional circumstances such as on happening of a force majeure event, We may decide to waive all or any of the requirements set out in Clause 3.1 of Part F.
- 3.5. The Claimant is required to intimate Us along with necessary documents as mentioned above, regarding a claim under the Policy, at the earliest possible time either in person or through online mode or Our distribution channel or authorized call centre. 4 DECLARATION OF THE CORRECT AGE

Declaration of the correct Age and/ or gender of the Life Insured is important for Our underwriting process and calculation of Premiums payable under the Policy. If the Age and/or gender declared in the Proposal Form is found to be incorrect at any time during the Policy Term or at the time of claim, We may revise the Premium with interest and/or applicable benefits payable under the Policy in accordance with the premium and benefits that would have been payable, if the correct Age and/ or gender would have made the Life Insured eligible to be covered under the Policy on the Date of Commencement of Risk.

5 FRAUD, MIS-STATEMENT AND FORFEITURE

Fraud, mis-statement and forfeiture would be dealt with in accordance with provisions of Section 45 of the Insurance Act, 1938 as amended from time to time. [A leaflet containing the simplified version of the provisions of the above section is enclosed in Annexure -(1) for reference]

6 SUICIDE EXCLUSION

Notwithstanding anything stated herein, if the Life Insured commits suicide, within 12 (Twelve) months from the Date of Commencement of Risk of Policy or from the date of Revival of this Policy, as applicable, all risks and benefits under this Policy shall cease immediately and We shall only pay the following to the Claimant, provided that the Policy is in force:

Higher of the Surrender Value as on the date of death or the sum of (Total Premiums Paid plus loadings for modal premiums and Underwriting Extra Premium, if any, paid till the date of death).

If You chose to increase Sum Assured on Death under the Voluntary Sum Assured Top-Up Benefit, the above suicide clause provisions will be applicable on the increased Sum Assured on Death as well. Hence, if the Life Insured commits suicide within 12 months, whether minor or major, whether sane or insane, from the date of increase in Sum Assured on Death benefit due to Voluntary Sum Assured Top-Up Benefit Option, the Claimant will receive higher of Surrender Value or the Sum Assured on Death under the base Policy (subject to the Clause above) plus return of sum of additional Total Premiums Paid, loading for modal premium and Underwriting Extra Premium, that was received towards increase the Sum Assured on Death under Voluntary Sum Assured Top-Up Benefit Option till the date of death. The increased Sum Assured on Death due to Voluntary Sum Assured Top-Up Benefit Option will not be paid as suicide happened within 12 months of increase in Sum Assured on Death.

7 TRAVEL AND OCCUPATION

There are no restrictions on travel or occupation under this Policy.

8. NOMINATION

Nomination is allowed as per Section 39 of the Insurance Act, 1938 as amended from time to time. [A leaflet containing the simplified version of the provisions of the above section is enclosed in Annexure – (2) for reference. You may request for a cancellation or change of nomination(s) for a Policy along with necessary details of substituted nominee. Additional charges, not exceeding Rs. 100/- on each occasion may be applicable for cancellation or change of nominee. This option is not available in case the Policy is sold under Married Woman's Property Act, 1874.

9. ASSIGNMENT

Assignment is allowed as per Section 38 of the Insurance Act, 1938 as amended from time to time. [A leaflet containing the simplified version of the provisions of the above section is enclosed in Annexure -(3) for reference]. You may request for written acknowledgement of the receipt of notice of assignment or transfer assignment for a Policy along with the necessary details and documents. Additional charges, not exceeding Rs. 100/- on each occasion may be applicable for granting a written acknowledgement of the receipt of notice of assignment. This option is not available in case the Policy is sold under Married Woman's Property Act, 1874.

10. POLICY CURRENCY

This Policy is denominated in Indian Rupees. Any benefit/claim payments under the Policy will be made in Indian Rupees by Us or in any other currency in accordance with the applicable guidelines issued by the Reserve Bank of India from time to time.



11. ELECTRONIC TRANSACTIONS

You will comply with all the terms and conditions with respect to all transactions effected by or through facilities for conducting remote transactions including the internet, world wide web, electronic data interchange, call center, tele-service operations or by other means of telecommunication established by Us or on Our behalf, for and in respect of the Policy or services, which will constitute legally binding and valid transactions when executed in adherence to and in compliance with the terms and conditions for such facilities.

12. AMENDMENT

No amendments to the Policy will be effective, unless such amendments are expressly approved in writing by Us and/or by the IRDAI wherever applicable.

13. REGULATORY AND JUDICIAL INTERVENTION

If any competent regulatory body or judicial body imposes any condition on the Policy for any reason, We are bound to follow the same which may include suspension of all benefits and obligations under the Policy.

14. COMMUNICATION AND NOTICES

- **14.1** All notices meant for Us should be in writing and delivered to Our address as mentioned in Part G or such other address as We may notify from time to time. You should mention the correct Policy number in all communications including communications with respect to Premium remittances made by You.
- **14.2** All notices meant for You will be in writing and will be sent by Us to Your address as shown in the Schedule or as communicated by You and registered with Us. We may send You notices by post, courier, hand delivery, fax or e-mail/electronic mode or by any other means as determined by Us. If You change Your address, or if the address of the nominee changes, You must notify Us immediately. Failure in timely notification of change of address could result in a delay in processing of benefits payable under the Policy.
- 14.3. For any updates, please visit Our website www.axismaxlife.com.

15. GOVERNING LAW AND JURISDICTION

The Policy will be governed by and enforced in accordance with the laws of India. The competent courts in India will have exclusive jurisdiction in all matters and causes arising out of the Policy.

16. ISSUANCE OF DUPLICATE POLICY

You may request for a duplicate copy of the Policy to Us along with relevant documents. Additional charges, not exceeding Rs.250/may be applicable for issuance of the duplicate Policy.

17. TRANSLATION

In the event of any conflict or discrepancy between any translated version and the English language version of this Policy contract, the English language version of this Policy contract shall prevail.

If the complainant are not satisfied with the redressal or there is no response within a period of 1 (One) month, or within 1 year after rejection of complaint by Us, the complainant may approach Insurance Ombudsman at the address mentioned in Annexure A or on the IRDAI website <u>www.irdai.gov.in</u> or on Council of Insurance Ombudsmen website at <u>www.cioins.co.in</u>, if the grievance pertains to:
 - 1.3.1. delay in settlement of a claim beyond the time specified by Us;
 - 1.3.2. any partial or total repudiation of a claim by Us;
 - 1.3.3. dispute over Premium paid or payable in terms of the Policy; or
 - 1.3.4. misrepresentation of Policy terms and conditions at any time in the Policy document or Policy contract;
 - 1.3.5. legal construction of the Policy, in so far as such dispute relate to a claim;
 - 1.3.6. Policy servicing by Us, Our agents or intermediaries;
 - 1.3.7. issuance of insurance Policy, which is not in conformity with the Proposal Form submitted by You;
 - 1.3.8. non issuance of any insurance document after receipt of the Premium.
 - 1.3.9. Any other matter resulting from non-observance of or non-adherence to the provisions of any regulations made by the IRDAI with regard to protection of policyholders' interests or otherwise, or of any circulars, guidelines or instructions issued by the IRDAI or of the terms and conditions of the Policy contract, in so far as they relate to issues mentioned in this para 1.3 above.
- 1.4. As per Rule 14 of the Insurance Ombudsman Rules, 2017, a complaint to the Insurance Ombudsman can be made only within a period of 1 (One) year after receipt of Our rejection of the representation or after receipt of Our decision which is not to Your satisfaction or if We fail to furnish reply after expiry of a period of one month from the date of receipt of the written representation of the complainant, provided the complaint is not on the same matter, for which any proceedings before any court, or consumer forum or arbitrator is pending.

Annexure 1

Section 45 - Policy shall not be called in question on the ground of mis-statement after three years

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended from time to time are as follows: 1.No Policy of Life Insurance shall be called in question on any ground whatsoever after expiry of 3 yrs from a. the date of issuance of policy or b. the date of commencement of risk or c.the date of revival of policy or d. the date of rider to the policy, whichever is later. 2. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from a the date of issuance of policy or b.the date of commencement of risk or c.the date of revival of policy or d. the date of rider to the policy, whichever is later. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based. 3. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy: a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;b. The active concealment of a fact by the insured having knowledge or belief of the fact; c.Any other act fitted to deceive; and d.Any such act or omission as the law specifically declares to be fraudulent. 4.Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak. 5. No Insurer shall repudiate a life insurance policy on the ground of fraud, if the insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries. 6.Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.7. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignces of insured, within a period of 90 days from the date of repudiation.8.Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.9. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.

Annexure 2

Section 39 - Nomination by Policyholder

Nomination of a life insurance policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows: 1. The policyholder of a life insurance policy on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.2. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment is to be laid down by the insurer. 3. Nomination can be made at any time before the maturity of the policy. 4. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.5. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be. 6.A notice in writing of change or cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.7. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.8.On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof. 9.A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will get affected to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate. 12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s). 13. Where the policyholder whose life is insured nominates hia.parents or b.spouse or c.children ord.spouse and childrene.or any of them, the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s). 15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Act 2015. 16.If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy. 17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874, applies or has at any time applied except where before or after Insurance Act, 1938, as amended from time to time, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

Annexure 3

Section 38 - Assignment and Transfer of Insurance Policies

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows: 1. This policy may be transferred/assigned, wholly or in part, with or without consideration. 2. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.3. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made. 4. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness. 5. The transfer or assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer. 6. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations. 7. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice. 8. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced. 9. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is a not bonafide; b not in the interest of the policyholder; c.not in public interest; or d.is for the purpose of trading of the insurance policy. 10. Before refusing to act upon endorsement, the insurer should record the reasons in writing and communicate the same in writing to policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment. 11.In case of refusal to act upon the endorsement by the insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the insurer. 12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to the Authority. 13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except a where assignment or transfer is subject to terms and conditions of transfer or assignment OR b where the transfer or assignment is made upon condition that i the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured; orii the insured surviving the term of the policy. Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position. 14.In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such persona shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment; b.may institute any proceedings in relation to the policy; and c.obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings. 15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Act, 2015 shall not be affected by this section.
